## Purpose and Certification

The WC and WCX are designed to test the natural working ability of Golden Retrievers and will be conducted in accordance with the AKC Field Trial rules as modified by the GRCA.

**\*\*Non-Golden Retriever Participants\*\*** - the host committee does not submit results of non-Goldens to the GRCA WC/WCX committee with final reports. Non-Golden owners are responsible for handling the necessary paperwork for certificates and approval from their specific parent breed club.

## WC/WCX Test Regulations

Copies of the complete WC/WCX requirements will be at the test headquarters and are also available online at: <http://gcgrc.org/WCWCXregs/>. Gun handling is not required and white clothing may be worn by the dog handler. Arrive on time in order to hear the judges' instructions to the handlers. Dogs will be run in catalog order, unless otherwise requested by the judges.

\*wingers may be used in the WCX test at the judges' discretion

## Directions to Test Site

**Wilmington, OH is located about 25 miles southeast of Dayton, OH and about 30 miles northeast of Cincinnati, OH, easily accessible from I-75 or I-71.**

**From I-75:** Take Exit #41, turn east onto Austin Blvd/Miamisburg Springboro Rd., after ½ mile turn south onto Springboro Pike/OH-741S., turn east onto E. Central Ave/OH-73, continue to follow OH-73 S. for 15 miles, turn east onto Brimstone Road.

**From I-71:** Take Exit # 45 toward Waynesville/Wilmington, turn north onto OH-73, after 2 ½ miles turn east onto Brimstone Road.

## Lunches

GCGRC will also host a cook-out for donations. Food is available within a 10-minute drive of the site. Alcoholic beverages are not permitted on the grounds prior to the conclusion of the test.
